President Rice opened the annual meeting with a prayer. This was followed by the officer's reports, election of officers, (listed above) and selection of "Old Sturbridge Village" as the meeting place for 1964. Details of the reports will follow.

PRESIDENT'S ities as President, Editor of the News Letter and as a member of the REPORT Committee working on the new Rice Genealogy. As president the duties had been comparatively light, consisting mainly in conducting the annual meeting. No momentous decisions had been made.

Two News Letters had been issued since the last meeting. The first covering details of the annual reunion and both continued the genealogy material that supplemented Ward's book, such as additional children, dates, places and marriages that Ward had not known about. Nothing was carried forward since that will be the function of the new genealogy.

With respect to the new genealogy! The loss of Mrs. Elsie Hawes Smith was a tragedy and one it will take time to overcome. All her records were promptly turned over

to the President and he, with Mrs. Rice, have been devoting long hours each day reconciling the two records. Here Smith received many lineages while from other sources, covering the same and link, lineages were received by the president. Naturally many differences developed in names, dates and places. The result was correspondence or reference to vital and other records where available.

After working all winter on Rice records the President and Mrs. Rice left for Florida in April, hoping the warm weather would be good for their arthritic conditions. After Florida they traveled with their trailer about the country and in Carada all summer, only returning in time for the annual meeting.

The President expressed his profound thanks to the officers and past-presidents who came forward and worked out the details for the annual meeting. He mentioned in particular Mrs Margaret Motrell for securing the meeting place; Mr. & Mrs. Edgar W. Rice for taking charge of the luncheon and entertainment; Stanley I Rice for handling sale of the reprinted Andrew Ward book and securing the programs; Donald H. Whittemore in securing the badges; Russell J. Rice for securing the flowers and conducting the tour to Edmund Rice's grave; Sturgis Rice for keeping us supplied with addressograph places and handling the sale of small books; to the ladies who helped register those at the ladies who helped register those at the ladies and Mrs. Helen Randall in her performance as secretary and treasurer.

TREASURER'S We believe that our members are vitally interested in our finances and for the first time we include the Treasurer's report. The Association has planned on issuing a new genealogy but that takes money so this report is made to let our members see what we have.

FINANCING The Chairman of the Publication Committee, Mr. Stanley I. Rice, express ed the opinion that the cost of the new book would run in the neigh-hood of \$5,000. Many of those present stated they would be willing to advance money on their books, if they only had some idea what the cost per book would be. The best estimate at this time would be \$15.00 per copy and persons sending in advance payments would naturally receive any pre-issue credits that could be given. Money for the books should be sent to Stanley I. Rice, 16 Longmeadow Ave Worcester 6, Mass. He will record the order and forward money to Treasurer.

MEMORIAL In 1958 the Association was asked if it would accept money in memorium to a deceased member. The answer was "YES". This money to be placed in the special book fund for the new genealogy. The Publication Committee plans a special "IN MEMORIUM" page in the new book. Donations should be sent to Stanley I. Rice.

NEWS During the past few years our membership has more than doubled. The of letter ficers and committee chairman have been very frugal with their expenditures. For instance the Editor purchased a mimeograph with his own funds so the cost of the News Letters covered only materials and postage. We have held

the News Letters down to two a year. Why are we telling you this? Merely to let you know that every penny saved means more towards the printing costs of the new book.

We have requested the membership to 100 us names of descendants so copies of the News Letter would go out to them. Now that they have received one or more copies and have not taken steps to help with the work by sending in a membership application we MUST drop them from our mailing list. INCORPORATION A letter from Sturgis C. Rice stated that he had the Association CHARTER Charter. The President recommended that steps be taken to determine what should be done to place the corporation in good standing with the State of Massachusetts. By vote of the members the officers were empowered to take such steps as they deemed necessary to be restored in good standing.

Our new Vice-President Ray Lowther Ellis checked in the State House and found that by filling out seven reports covering years 1957-1963 and upon payment of five dol lars for each year that we would be restored to good standing. The papers are presently being typed and signed.

Forms for use in paying dues and purchasing books will be found on page 7. There is still time to order books for Xmas presents.

We are devoting an extra page to Association affairs just to give our membership an idea of what is going on. Our committees are working hard on your behalf and

we trust you will support them in ever way possible - including payment of dues, sending in advance payment on the new genealogy, adding someone's name on the "In Mamoriam" page or, as a number have, remitted a little extra as a gift for the book fund.

The committee working on the new book notes that many dates (births, INNEACHES marriages and deaths) are missing from material submitted. Places are also important in adding forms generations in tracing their ancestors.
