## President's Column

Greetings, cousins!

Let me tell you a tale of technology. As those of you know who have attended reunions, or even just carefully read the schedule of a reunion, the Association has a Board of Directors which meets every year during the reunion, generally after dinner on Friday evening, instead of lingering over dessert with everyone else. You can probably also guess that we meet in the spring as well, to plan the next reunion. The spring meetings, however, do not take place in a context with other activities, and many of the officers and directors live far afield, and so attendance at these meetings would be a problem if we had no alternative to physical presence. Indeed, even the directors who live close by may have difficulties in being physically present at some meetings (as I did for my very first meeting as a director).

The solution, of course, is the teleconference. Various telephone companies offer services whereby multiple callers can dial a toll-free number and connect to a conference call, and every participant can hear and contribute to the discussion, including the physical attendees clustered around the speakerphone at the meeting place. There are even videoconferences available these days, but that's another story, since those require more equipment than an ordinary telephone. In any case, I attended my first board meeting by telephone.

Then again, there are hazards lurking in the technology. At our latest meeting, held in a high-tech conference room, we were faced with a compatibility problem. The room had an internet connection and a speakerphone with a very short cable connecting it to the wall outlet. I had brought a telephone with a set of long phone cords that would easily reach from any wall to the middle of the conference table, but the wall outlet was an ethernet jack, and so my cords wouldn't connect either to the wall or to the room's own internet phone. What to do? Fortunately, Dale Gunn, who was our local host and had arranged for this meeting room, knew of a nearby store where he could go to buy the kind of cable we needed, and the day was saved. We were able to sit down comfortably around the table and discuss with our distant colleagues and plan for the upcoming reunion. Hope to see you there!

### Membership

The Edmund Rice (1638) Association, Inc. is governed by a Board of Directors, of at least five members, elected at the annual reunion and meeting, usually held on a weekend in September.

Descendants of Edmund Rice were holding reunions as early as 1851, but it was not until 1912 that the Association was formed and officers elected. Incorporation under Massachusetts law took place in 1934.

Membership is open to anyone who claims to be a lineal descendant of Edmund Rice. Rigorous proof is not required and many members have been able to ascertain their pedigree only after access to the books and files of other members. Spouses are also eligible for membership.

### EDITOR'S COLUMN

During the spring Board of Directors meeting, they discussed the current cash flow deficit. One reason for the large deficit is that the charges for 2016 reunion attendees did not cover the full costs of meals and due to the fact that the association has not raised dues to keep up with mounting costs and also the actuarial unsoundness of the lifetime membership charge.

After much discussion, it was moved, seconded and passed unanimously to raise the annual dues to \$20 (\$10 for seniors) and to raise the fee for a life membership to \$300, all as of the 2017-2018 dues year, but not applying to any dues already paid in advance.
